

CursorPlus - Terms and Conditions

CursorPlus is an image magnifier widget for Wix websites that provides:

- Hover-activated image zoom functionality
- Customizable lens size and zoom levels
- Optional WebGL fisheye distortion effects
- Optional glass glare effects
- CMS and dynamic content integration

3. License

We grant you a limited, non-exclusive, non-transferable, revocable license to use CursorPlus on your Wix website(s) in accordance with these Terms and any applicable Wix policies.

You may use CursorPlus to:

- Add image magnification functionality to your Wix website
